The Investec USD S&P 500® Digital Plus ESP ("Digital Plus ESP") is a structured product issued by Investec Bank Limited ("IBL") and listed on the JSE Limited ("JSE").

The ESP is designed to provide a minimum return of 21.7% in US Dollars if the S&P 500 Index performance is flat or positive over the 3.5-year term of the investment. At maturity, if the Final Index level is higher than the Initial Index level at inception but growth is less than 21.7%, the Digital Plus will pay the investor a return of 21.7%

In addition, if the growth in the Index exceeds 21.7%, the investor will also receive the excess growth in the Index, simply put; returns are unlimited and will not be capped. The investor's return is calculated in US Dollars and settled in Rand.
