How it works

Earn at a higher rate

PARTNERSHIP LEVEL AND EARN RATE

The good news is that you can increase your earn rate. Your partnership level determines your earn rate. There are five partnership levels. The higher your partnership level, the higher your earn rate.

LEVEL EARN RATE

1 Rewards point for every **R20** of qualifying transactions and 1 Rewards point for every **R2 000** of qualifying balances

1 Rewards point for every R10 of qualifying transactions and 1 Rewards point for every R1 000 of qualifying balances

1 Rewards point for every R7 of qualifying transactions and 1 Rewards point for every R700 of qualifying balances

1 Rewards point for every **R5** of qualifying transactions and 1 Rewards point for every **R500** of qualifying balances

1 Rewards point for every **R4** of qualifying transactions and 1 Rewards point for every **R400** of qualifying balances

PARTNERSHIP SCORE

Your partnership level is determined by your partnership score, which is based on the number of Investec products you hold and your product balances. As you increase your partnership score, you can move up a partnership level.

When you add a product or increase your existing product balances, you contribute to your partnership score.

MINIMUM MONTHLY DEPOSIT REQUIREMENT

To activate your partnership score and access partnership levels 2 to 5, you need to meet the minimum monthly deposit requirement:

- Investec Private Bank Account: R35 000
- Investec Private Bank Account for young professionals (if you're under 30): R10 000
- Investec Private Bank Guaranteed Account: R10 000
